the 1950s. This is criminal! It's outrageous! But that's the way it is. This is how it's developed and I wanted to let you know that his new facility, The Cube is—I have an engineer that I've met with who works in that facility, and they work on not just the propulsion systems, but also the electronic warfare systems and the bio nanotechnology, which I'll get to after our break, the things that the UFO retail world, books, movies and conferences would call aliens. These are man-made. They have integrated circuits in their brains and they walk around. They're little grey or reptilian or creepy-looking things. These are man-made—100%—and I know the men working on that, but The Cube is associated with that. Another is Dulce and another is Pine Gap. The other, of course, we've all heard of Nellis Complex. It's Area 51, more specifically, it's S-4 or S-9 and S-12. Those are compartmented areas. You have to have a password and biometrics to get into them. Pahute Mesa and Area 19 and Groom Lake. These are all things that have been provided to our government officials.

In New Mexico, you have Los Alamos National Laboratories. It has an underground connector—underground—that goes to the Dulce Complex, which most people think doesn't really exist, because you go to Dulce and there's nothing there. Remember this simple fact, nothing critical is above the surface of the ground. It's either in space or it's underground. Everything, including the White House facilities and the Pentagon. Everything critical is underground. The Kirtland Air Force Base has the Sandia National Laboratories and the Defense Nuclear Agency. Phillips Labs, Manzano Mountain Weapons Storage Facility and underground complex that connects Coyote Canyon Test Site (North end of Manzano), White Sands Complex, and again, the Dulce Complex, so Kirtland Air Force Base, and that's outside Albuquerque. I've been there.

In Arizona, a key facility is Fort Huachuca, an underground base, most of it that's critical. It's

Army Intelligence headquarters. There is a storage facility where a man, as of the 1970s, who was on my team, worked in it, and at that time they had nine extraterrestrial spacecraft that had been downed using these electromagnetic pulse scalar weapons and a whole lot of different ET species that were frozen there. That's at Fort Huachuca, ironically, near Tombstone. The other ones I just want to mention, Cheyenne Mountain Deep Space Network, which is under the mountain in Colorado Springs, has a dedicated area for just the Deep Space Network tracking of interstellars that are in our solar system. One of my military advisors, a man who's been in many of these unacknowledged special access projects, was actually in that facility, and got to see this Console 50. He said they had tracked an object at that time that was in our solar system, that was 26 miles in diameter, an artificial ET object, moving as he put it, "under its own steam." He's a Navy guy. I said, "I don't think it's working with steam, but yeah, you're right." Another critical facility is the Lawrence Livermore Labs, the Pine Gap underground facility in Australia, I have a picture, actually, of the above-ground facility that a man who'd worked there sent to me. The

Redstone Arsenal Underground Complex in Alabama, that also has an association with the Marshall Space Flight Center, and in Utah, one of the most critical, the most critical one that's new is the Dugway Proving Grounds, outside Provo, Utah. This is classified air space above and no access by ground. Above ground, you don't see much...everything is underground.

Richard Foch, this Naval Research Lab official, was out there with some Generation five or six or whatever night scopes, doing an operation and he looked out and saw these objects coming out from underground that then zipped over him. These massive discs and triangular-shaped antigravity objects that were ours and some were just sitting out there, watching him. That's outside of Provo, in the desert. That one is very key, and is mostly manned by folks who are part of the Mormon corporate empire, which if I were to rank who has what kind of say-so over policy on

this, that would rank, certainly ahead of the president or Congress. I won't comment further than that...this is not to make an aspersion to rank-and-file Mormons. This is just how that operation works. The agencies in the US government that are associated with this...AFOSI (AIR Force Office of Special Investigation), compartmented operations at the CIA, the Defense Advanced Research Project (DARPA), the Defense Intelligence Agency (DIA), now notwithstanding, I briefed the general who is head of it. He wasn't given any information, but we had Disclosure Project witnesses who were DIA-assigned contractors who were very involved in ET and UFO technology issues. Certain compartmented operations at the FBI, being tightly held, and every military intelligence division (Army, Air Force, Navy) have compartmented unacknowledged operations that feed into this MAJIC committee. The NRO (National Reconnaissance Office) the NSA (National Security Agency), again, a very compartmented operation, certainly nothing that Edward Snowden had access to, to my knowledge, although, it's been asked, and the various space commands.

Private corporate entities include BDM Corporation; Bechtel Corporation does most of the underground base construction. I know that the tunnel that's being built from Los Alamos over to Dulce—for years people heard, and you can Google this, the Taos Hum. A lot of New-Agers thought it was Gaia singing or something. There's a massive nuclear-powered tunneling device, that was going from Los Alamos over to Dulce. It goes through bedrock and glassifies it into this massive tunnel that then anti-gravity, electromagnetic vehicles transport people—people carriers underneath the ground. As it was going through that bedrock, it caused this vibration. That was being operated by Bechtel, and I was at a meeting with Stephen Bechtel once, and they are very key. Booz-Allen and Hamilton is who Snowden worked for, but they are a key contractor. They do have a compartmented operation dealing with this. Boeing Aerospace, EG&G a very key

facility for creating electronics and also state-of-the-art nanotechnology implants that are put into abduction victims; people that think they had contact with ETs, but are actually being abducted by military and corporate folks. E-Systems, which is now a division of Raytheon; Lockheed-Martin I've mentioned; McDonnell Douglas is now part of Boeing; MITRE Corporation is very key in terms of anti-gravity and high-tech and is here in the D.C. area and other places. Northrup Grumman; I mentioned Phillips Labs before; Rockwell International; SAIC (Science Applications International, Corporation), now, this is one of the crown jewel. Admiral Bobby Ray Inman had been a member of this MAJIC committee for years, along with Dick Cheney and Papa Bush (George H. W. Bush), but at SAIC he had been National Security Head, and he moved from there over to the Board of SAIC. In a little side story interestingly, when I asked Senator Barry Goldwater, at his home some years ago—he had run for president in 1964, but always had an interest in this and never been told anything. We started comparing notes with who we knew, and he said, "How can I help you?" and I said, "If you could reach out to some of

these people on this MAJIC committee it'd be great." We named some names that he didn't know some of the ones I mentioned, and I said, Admiral Bobby Ray Inman and he says, "Oh, Bobby Ray, we've been friends for years." I said, "Well, get hold of him. Give him a jingle, would you?" So he did; biggest mistake of his life. He got hold of me and said, "I can't make any more phone calls like that for you." He tore me apart. He tore me a new one. But Admiral Inman, definitely a MAJIC member, as are other chief people on SAIC, but it's compartmentalized, so most people work on conventional things, there. At TRW; Village Super-Computing; Wackenhut Security there's a lot of security for MAJIC. And then, there are others, as well. Some of these, most people never heard of. They're huge and have enormous reach. I think what you have to understand is that they're certainly not limited to that list, but it feeds into a system. Most people don't even understand how it works. I always tell people to go back and look at the interview of

Denise McKenzie, who worked for SAIC. She got a job there as a clerical, administrative person in an office. It's kind of like the Mafia. You know how the Mafia will have like a pizza parlor or some little shop. They'll come in and that's the storefront, but they're laundering money and doing their drug deals and pimps through the back door. That's how this works. So, she was in this office at SAIC, and it was running multi-million dollar contracts for the US government. She said, "What is this, there's nothing going on here?" And she went to this file cabinet and there were all these dummied-up reports that would go back to Capitol Hill to justify the money. When she started asking about it, they said, "Don't ask about this." What she basically was told. "This office receives the money; we generate false reports back to the president and Congress. That money then passes out of this office to a Black Project dealing with UFO's, electronics, and antigravity, stuff like this." When you get to some of the accounting—I met recently with one of the Big 4 accounting firms, and they said, "Yeah, this is exactly how it works." They'll basically say, "Here's what we're doing"—and if you try to penetrate further to actually get to a granular

level of where the money is going, they'll say, "Well, you don't have a need to know. That's a top-secret, special-compartmented intelligence." Basically, you have to take their word for it. So it all gets rubber-stamped by the big four auditing firms, but it's very illegal. You'll remember in the film "Sirius," Donald Rumsfeld, the day before 9/11, I'm not sure he knew he was being filmed, said, "2.3 trillion dollars unaccounted for." Recently, I heard—found out from a good source, its \$8.5 trillion now. So, there's \$8.5 trillion that have basically been embezzled, misappropriated, used without the knowledge of Congress or the President. That's a lot of money even for America. So that is exactly how it operates, but if you take that one little example from SAIC and multiply it through all these corporations and all these different government offices, that's how the funding mechanism works. Does that make sense to folks? I hope that made sense to you guys.
